## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered into on 4/9/2019 by and between:

**Shree Santkrupa College of Pharmacy, Ghogaon, Tal. Karad Dist. Satara Maharashtra, India** - an institute which has B. Pharm., and M. Pharm. colleges FIRST PART. hereinafter called "SSCOP"

And

**Human Research Institute (HRI)** with Udyog Aadhaar Number - MH30D0009424 and having its administrative office at Rangtarang Nivas, Veer Line, Shastrinagar, Malkapur, Karad 415539 called Maharashtra, India - SECOND PART

(**Shree Santkrupa College of Pharmacy, Ghogaon AND Human Research Institute (HRI) Malkapur-Karad** are hereinafter individually referred to as 'Party' and collectively referred to as 'Parties')

**A. Background:**

**Party one Shree Santkrupa College of Pharmacy, Ghogaon, Tal. Karad Dist. Satara** established in 2004 by Shree Santkrupa Shikshan Sanstha, catering to B.Pharm, M.Pharm and Ph.D, courses effectively contributing to the health care system **Party two Human Research Institute (HRI) Malkapur-Karad**, is an organization in its respective professional field of training, organizing lectures and conducting one day Workshop etc.

**B. Duration:** The MOU shall be valid for Three year from effective date and thereafter it may be renewed on mutually agreed terms.

**C. Purpose:** Interaction between industry and institute is widely recognized as an essential requirement to integrate technological knowledge and skills in education. The MOU is being signed on the prospect that both the institutions collaborate on developing joint academic and research co-operation between two institutes. The purpose of this MOU is to provide education, training and guidance to the students of Shree Santkrupa College of Pharmacy, Ghogaon and providing recruitments of Employable Professionals and Research assistance for Human Research Institute (HRI) Malkapur-Karad for mutual benefit.

**D. Now this agreement witnessed as follows:**

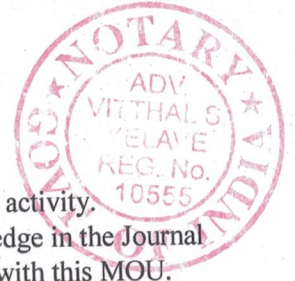
- The SSCOP has joined hands with the HRI for enhancement of skills through various lectures, training sessions and One Day Workshop to their students.
- This association will be for a period of 1 year commencing from the date of this agreement
- The SSCOP may advertise the HRI at its own cost and expenses by advertisements in newspapers, journals, magazines, Internet or by any other means.
- The SSCOP agrees to conduct One Day Workshop to inspire the students to enroll for HRI by paying Rs. 300 per participant which can be increased by mutual understanding and agrees for minimum 50 participants.
- The SSCOP and the HRI hereby agree to use each other's business Collaterals like Logos, photos, website URL etc in their individual Business Collaterals after mutual consent.
- Any and all disputes, controversies, differences arising between the parties hereto out of or in relation to this agreement or any breach thereof shall be finally settled by arbitration by two arbitrators, one to be appointed by each party to the dispute and the arbitrators shall, before taking upon themselves the burden of reference appoint an umpire. The award given by the arbitrators or umpire as the case may be, shall be, final and binding on the parties.

**E. Mutual responsibilities:**

- Both the parties shall appoint one person as point of contact for the execution of the all activity.
  - Any patent or research publication of the executed work by both parties shall acknowledge in the Journal.
  - Each party shall respect the other's intellectual property and shall use it in accordance with this MOU.
  - The schedule of the research, training guidance program will be decided by Shree Santkrupa College of Pharmacy, Ghogaon with Human Research Institute (HRI) Malkapur-Karad as per the availability of time and space.
  - If any financial aspects are involved It should be co-ordinated and approved by heads of both the parties and it should be spelt out clearly before starting the activity.
  - Each party shall be at liberty to terminate this MOU with a written notice period of one month to the other party without any compensation and seeking legal redress. In the event of termination both the parties have to discharge their obligations.
  - Any and all disputes or differences between parties shall always be resolved by mutual consultation only.
  - Any changes in implementation procedures which are not as per present MOU will be discussed and will be incorporated in agreement with two parties.
  - The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition(s) of this agreement
